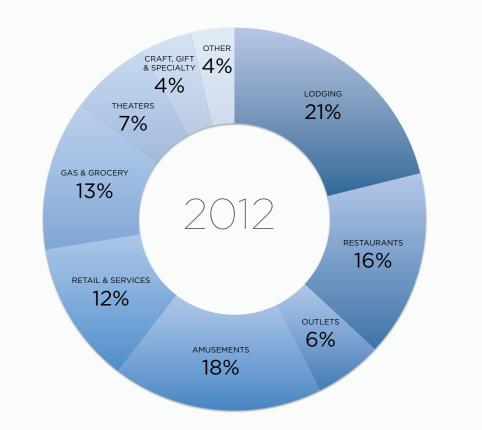
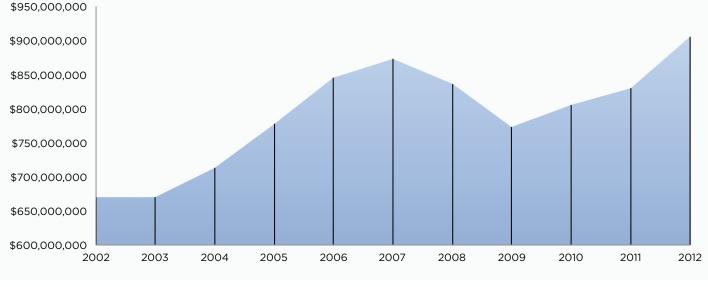
Each month, the city monitors revenue generated by each business sector. One of the strengths of Pigeon Forge is that it's not overly dependent on any single business sector because of the strong product mix, helping it continue to be successful as a destination. The city applies a 1% gross receipts tax that helps to generate revenue for the city budget. It accounted for 22% of the total city's budget revenue in 2012. If a category trends downward over a period of time, reasons are identified and strategies are evaluated and implemented to help reverse negative trends.
